A Vision Come to Life with Big Support



SaskAbilities Partners in Mental Health and Well-being hosts its first Mental Health Conference in 2022 and celebrates a new partnership with Dollar a Day Foundation.

2022 was the year for the SaskAbilities' Partners in Mental Health and Well-being services in Yorkton to shine a light on mental health in a big way! The Mental Health Conference had been a vision of Regional Director, Aleks Hoeber, and the team in Yorkton for many years. With the COVID-19 pandemic exasperating stress and mental health, 2022 seemed like an appropriate year to have important discussions on a topic that, unfortunately, is still stigmatized.

Hosted on October 5th, 2022 at the Gallagher Centre in Yorkton, the conference sold out in just six weeks with a waitlist of individuals hoping to take in the full-day event. "We gathered as a team in June and just made the decision that, yes, we are going to do this. There was definitely some talk and consideration to COVID-19 mandates, you can't predict what the future will hold but it was evident to us that this conference needed to happen. It was something that was needed in our community and we are already looking ahead. I'm confident in saying there will be another one in the future," exclaims Jamie Neal, Mental Health Senior Supervisor.

Following the World Health Organization's theme of Make Mental Health for All A Priority, the conference lineup boasted impactful

guest speakers including author and mental health advocate, Allan Kehler; inspirational speaker, Corlis Rassyle; and Executive Director of Canadian Mental Health Association Saskatchewan Division, Phyliss O'Connor. The day also included activities focused on wellness and self-care including laughing yoga led by Tim Barlow, a British Canadian songwriter and musician, with Kundalini yoga and meditation later in the afternoon led by local yoga instructor, Melissa Krochak.

"This was the first major conference to be hosted in Yorkton since the pandemic and feedback has been very positive. The community as a whole really came together to support us, including the Mayor of Yorkton, Mitch Hippsley who brought greetings on behalf of the City. MLA, Greg Ottenbreit, was there on behalf of the Government of Saskatchewan, and Cathay Wagantall, MP for Yorkton-Melville sent greetings. We had individuals and agencies from outside Yorkton travel to attend and lots of interest, a lot of people reaching out which was great to see for our first year," mentions Jamie who is quick to acknowledge the enormous team effort it took to plan and pull off a successful mental

25 Years of Quality, Care & Collaboration

It might not seem like an obvious partnership - Ag Growth International (AGI), a global agricultural business dedicated to "supplying the world's food infrastructure" - and SaskAbilities, a Saskatchewan-based non-profit organization with a mission to "support people experiencing disability with programs and services to enhance their lives." But sometimes, those unsuspecting duos can develop a meaningful collaboration that, in this case, has strengthened the southwest community by creating employment opportunities for those experiencing disability or barriers to employment.

Established in 1996 by Batco, AGI provides custom-designed farm and commercial systems to customers across six continents. The company has over thirty-five brands across five platforms - Seeds, Fertilizer, Grain, Feed, and Food. After one year in operation, the company contacted SaskAbilities Swift Current Branch to help create the first variation of the hopper cloth, an important component of AGI's line of grain conveyors. Today, Caridad Gonzales and her team of sewers are responsible for the manufacturing of sixty-two different designs that ultimately find their way across North America, Asia, Australia, Europe, Africa, and South America.

"Quality product; that's always first. Then being ahead of schedule - I always want to be more than a few days ahead of the scheduled delivery date. After that, fun! We are always smiling and laughing and having a good time because I want the team to enjoy their work and look forward to coming in each day. We even do some dancing and stretching to get our energy up," explains Caridad of the priorities and work environment in the sewing department that employs six parttime staff members including Marilyn Janzen who herself is celebrating 28 years in the



sewing department. Starting out as a client of SaskAbilities' Training Centre and making the shift in 2018 to part-time employee, Marilyn has worked on AGI's products since the beginning.

The relationship that has grown and evolved between SaskAbilities and AGI and is one that is very much rooted in mutual interest, inclusivity, and trust. "To have a partnership that is able to not only withstand but prosper in the shifting global demand of business in agriculture is something to be celebrated. AGI Swift Current (Batco Manufacturing) has worked closely with SaskAbilities for these 25 years, and the success of our relationship is embedded in the mutual interest in each other's work, facility and business model," explains Renee Rude who is proud to reaffirm AGI's commitment to initiatives that promote inclusion and employment of individuals experiencing disability or barriers to employment.



With a relationship spanning 20 years, the Saskatchewan Automobile Dealer's Association (SADA) made its first contribution to Camp Easter Seal in 2003, and their generosity and support have continued ever since, contributing over \$571,000 to SaskAbilities since then!
