The event also highlighted and celebrated the many successes of Partners in Employment program participants currently working in various roles for the City of Saskatoon. One of those individuals included Drew, who accessed Partners in Employment services in 2019 and was hired to work in the custodial department at Saskatoon Police Service in 2020. Drew's supervisor shared with those in attendance his remarkable growth and how he is an excellent example of what good can

happen when the community invests in diversity. "It was hard at first, but it got easier over time. I really like my job as a custodian; the people I work with sometimes go watch hockey games and go bowling. It's nice to feel included in those things outside of work," explains Drew of the meaningful relationships he's built with his colleagues over the past three years.

While the freshly signed partnership agreement is new, the collaboration between SaskAbilities and the City of Saskatoon is not. Since 2019, Partners in Employment and the City of Saskatoon have worked closely to provide meaningful employment for over 13 program participants. The partnership agreement aims to "identify and explore opportunities to increase the employment of individuals experiencing disability in Saskatoon and area through cooperative initiatives. It will continue to explore opportunities to strengthen and develop business opportunities between the City of Saskatoon and the SaskAbilities' Saskatoon Branch." 🚺

Inclusivity and Accessibility at the Forefront of Rebrand for Stinger Sports

Stinger Sports is a leading manufacturer of ringette equipment. Trusted by over 80 retailers nationwide, the brand has some notable partners in the sport, including Ringette Canada. Owned and operated by SaskAbilities since its purchase in the 1990s, the nonprofit organization has grown Stinger Sports into a full-service ringette equipment manufacturer, with proceeds going towards programs and services that enrich the lives of people experiencing disability across Saskatchewan. While the brand has grown over the past three decades, not much has changed with Stinger's branding and image until now.

Recently, discussions around inclusivity and accessibility have been at the forefront when considering a brand refresh for Stinger Sports.



Anthony Thompson, Senior Supervisor at the Regina Business Centre, is managing the changes and shares an update, saying, "This year, we decided to move forward with a full relaunch of the Stinger Sports website and rebrand with a new logo, something that depicts inclusivity and aligns with SaskAbilities. Customers visiting the website will enjoy a new and improved experience. The motivation for the changes is to ensure the brand's image matches the products' quality and is representative of Stinger Sports today. We want the products to be more accessible and our customers' experience to be positive always, whether they are ordering ringette gear online or talking to us directly."

With "business as usual" on the production side, things haven't slowed down a bit for Stinger Sports, which means the sewing department is in full swing making ringette stick bags, Mosspro pants, Pro pants, and Padda girdles. Kyra, an employee with SaskAbilities, has worked in the sewing department for nearly ten years and is excited to challenge herself with more Stinger Sports gear. "I mostly focus on the pants, but I'm hoping to be able to move on to the girdles, which are a lot more difficult to make." With a supportive team in the sewing department, Kyra is confident that she'll be making high-quality girdles for ringette athletes a vear from now.

With the anticipated changes in customer support and the brand refresh, Anthony is hopeful companies and individuals will be interested in learning more about Stinger Sports. "I think our customers are interested to know we are an organization that hires people experiencing disability and barriers to employment. Customers want to know where their money is going, beyond purchasing high-quality items. I'm confident our customers will continue to support the Stinger Sports brand, knowing their dollars are returning to the community to support people and enrich their lives in different ways."

Specialized Seating Program Recognized by CAOT in Saskatchewan

The Canadian Association of Occupational Therapists (CAOT) and CAOT-Saskatchewan recognized the Specialized Seating Program at Rehabilitation Services in May of 2023 for the team's "contribution and support to the profession of occupational therapy" in Saskatchewan.
